THE FAMILIES ALSO HAVE ACCESS TO SHOWER FACILITIES, CASE MANAGEMENT SERVICES AND PARENTING CLASSES. THE LOWDON SCHUTTS WOMEN & CHILDREN EMERGENCY SHELTER PROGRAM WITH COOK'S CHILDREN'S HOSPITAL WHICH MEETS WITH CLIENTS WEEKLY TO ASSESS THEIR HEALTH AND WELL BEING. IN ADDITION TO A PROGRAM MANAGER, THREE CASE MANAGERS WORK WITH THE PARENT TO ENSURE COMPLIANCE WITH THE LOCAL SCHOOL DISTRICT GUIDELINES AND CONDUCTING ACTIVITIES TO ENHANCE THE CHILD'S OVERALL WELL BEING. CASE MANAGEMENT SERVICES INCLUDE ASSISTANCE WITH SECURING HOUSING, EMPLOYMENT AND SECURING ADDITIONAL INCOME (FOOD STAMPS, SSI, SSDI, ETC.) FOR THOSE ABLE TO WORK. CASE MANAGERS ALSO ASSIST CLIENTS WITH OBTAINING CRITICAL DOCUMENTS SUCH AS SOCIAL SECURITY CARDS, BIRTH CERTIFICATES AND STATE IDENTIFICATION. IN 2010, PNS SERVED 212 SINGLE PARENT FAMILIES WHICH INCLUDED 421 CHILDREN.

THE OBJECTIVES OF THE LOWDON SCHUTT'S WOMEN & CHILDREN EMERGENCY SHELTER PROGRAM ARE 1. TO MOVE CONSUMERS OUT OF THE CYCLE OF HOMELESSNESS, 2. TO INCREASE PARENTING SKILLS AND 3. TO DECREASE THE NEED FOR CRISIS INTERVENTION WITH THESE FAMILIES INCLUDING REFERRALS TO CPS AND CALLS FOR EMERGENCY SERVICES.

SAFE HAVEN SUPPORTIVE HOUSING SERVES CUSTOMERS WITH SPECIAL NEEDS RELATED TO MENTAL HEALTH.
